GREENACRES BOWL MONDAY NIGHT BASEBALL LEAGUE – SUMMER 2026

THE MONDAY NIGHT BASEBALL LEAGUE WILL BE SANCTIONED BY USBC AND DUES MUST BE PAID BY THE FIRST WEEK OF BOWLING. THE LEAGUE WILL BOWL EVERY MONDAY STARTING ON JUNE 1ST, 2026 AND CONTINUE FOR 14 WEEKS. THE LAST NIGHT OF BOWLING IS AUGUST 31ST, 2026. THERE WILL BE TWO DIVISIONS.

PRACTICE TIME WILL START AT 7PM AND BOWLING FOR SCORE AT 7:10PM.

THE BOARD OF DIRECTORS CONSISTING OF THE LEAGUE OFFICERS AND TEAM CAPTAINS SHALL ASSIST THE MANAGEMENT OF THE LEAGUE. EACH BOARD MEMBER SHALL HAVE ONE VOTE.

- 1) LEAGUE FUNDS: THE LEAGUE SHALL BANK WITH TRUIST, CHECKS MADE PAYABLE TO PT BOWLING. NO CHECKS THE LAST 2 WEEKS MONEY IS DUE (WKS 11 & 12). LEAGUE FEES WILL BE \$33 WEEKLY. THE TEAM SPONSOR FEE IS \$100. BREAKDOWN OF COST PER WEEK IS: LINEAGE \$14.00. PRIZE FUND \$17.50. SECRETARY FEE \$1.50. FOR A TOTAL OF \$33. THE LAST 2 WEEKS OF BOWLING IS DUE BY THE 10TH WEEK OF BOWLING (8/3/26). TEAM SPONSOR FEE \$100, DUE BY THE 5TH WEEK OF BOWLING (6/29/26).**
- 2) USBC SANCTION FEES: USBC FEES ARE \$27 FOR FULL MEMBERSHIP AND \$10 FOR BASIC (THIS LEAGUE ONLY & NOT ELIGIBLE FOR ANY HONOR SCORES). SANCTION ID NUMBERS MUST BE FILLED OUT ON SANCTION CARD.**
- 3) ENTERING AVERAGES: ENTERING AVERAGES MUST CONSIST OF 21 GAMES OR MORE., NON-SANCTIONED AVERAGES WILL BE**

ACCEPTED BUT SANCTIONED AVERAGES SUPERSEDE WITH THE CRITERIA BELOW, IN HOUSE FIRST:

A) AVERAGE FROM GREENACRES BOWL LATEST NFL LEAGUE (2025/2026).

B) LAST YEAR'S MONDAY NIGHT BASEBALL AVERAGE (SUMMER 2025).

C) HIGHEST 2025/2026 VERIFIED AVERAGE.

D) HIGHEST 2024/2025 VERIFIED AVERAGE.

E) HIGHEST 2023/2024 VERIFIED AVERAGE.

F) IF NO VERIFIABLE AVERAGE, BOWLERS WILL ENTER AN AVERAGE OF: MEN 200, WOMEN 180 ON THE FIRST NIGHT OF BOWLING AND USE THAT AVERAGE AS ENTERING AVERAGE.

G) VERIFIED ENTERING AVERAGES WILL BE USED FOR THE FIRST THREE (3) GAMES. UN-VERIFIED AVERAGES (200 OR 180) WILL BE HELD FOR SIX (6) GAMES. THEREAFTER, YOU WILL USE YOUR CURRENT LEAGUE AVERAGE. NO BOWLER WILL BE ALLOWED TO DROP HIS/HER AVERAGE MORE THAN 10 PINS FROM THEIR ENTERING AVERAGE FOR HANDICAP PURPOSES. THERE WILL BE A 10 PIN CAP ON THE INCREASE OF VERIFIED AVERAGES FOR THE FIRST NINE (9) GAMES. THE LEAGUE HAS THE RIGHT TO RE-RATE A BOWLER AT ANY TIME. A NEW BOWLER WHO HAS NEVER BOWLED AND HAS NEVER HAD A MEMBER ID NUMBER WITH USBC WILL BOWL 3 GAMES THE FIRST NIGHT AND ESTABLISH AN AVERAGE FOR THE 2ND WEEK OF LEAGUE AND WILL BE APPROVED BY THE SECRETARY. THE FIRST NIGHT THE NEW BOWLER WILL USE (200/180) FOR UN-VERIFIED AVERAGES.

4) HANDICAP: THE TEAM HANDICAP WILL BE THE SUM OF ALL BOWLER'S HANDICAPS BASED ON 90% OF 240.

5) TEAM ROSTER: THE TEAM ROSTER WILL CONSIST OF (4) BOWLERS, ANY COMBINATION OF MALES AND/OR FEMALES. ANY ROSTER CHANGES MUST BE REPORTED TO THE SECRETARY BEFORE THE NEW BOWLER BOWLS. NEW MEMBERS MAY NOT BE

ADDED TO A ROSTER ON POSITION ROUNDS NIGHT, MUST BE ADDED UP TO THE NIGHT BEFORE. WE WILL HAVE A SIX (6) MAN ROSTER. ALL BOWLERS MUST HAVE AN ESTABLISHED ENTERING AVERAGE IN ORDER TO BOWL ON POSITION ROUNDS. PLEASE RECORD ROSTER BOWLERS ON THE SCORE SHEET.

- 6) SUBSTITUTIONS: SUBS WILL BE PERMITTED. THE TEAM CAPTAIN WILL NOTIFY THE SECRETARY OF ANY SUBS BEFORE BOWLING. USBC RULE STATES THAT ALL BOWLERS PARTICIPATING IN A SANCTIONED LEAGUE MUST COMPLETE A SANCTION CARD AND PAY OR PROVIDE PROOF OF MEMBERSHIP FOR THE CURRENT YEAR BEFORE THE COMPLETION OF THE PLAYER'S FIRST SERIES. FAILURE TO DO SO MAY RESULT IN A FORFEIT. SUBS ARE NOT PERMITTED TO BOWL POSTION ROUNDS, MUST BE ON THE ROSTER. IN ADDITION, A SUB IS NOT RESPONSIBLE FOR BOWLING FEES. ALL SUBS MUST HAVE A VERIFIABLE BOOK AVERAGE.**
- 7) LEGAL LINEUP: A LEGAL LINEUP WILL CONSIST OF TWO (2) REGULAR MEMBERS. SEE RULE 109(A). THE TEAM HIGHER IN THE STANDINGS MUST SET THEIR LINEUP FIRST FOR WEEKLY MATCHUPS.**
- 8) FORFEITURE: SEE USBC RULE 110(C).**
- 9) VACANCY / ABSENTEE SCORES: THE ABSENTEE SCORE WILL BE 10 PINS MINUS THE BOWLER'S AVERAGE. A VACANT SCORE IS 150.**
- 10) POSTPONEMENTS: POSTPONEMENTS AND PRE-BOWLING WILL BE GRANTED AS OUTLINED IN USBC RULES. THERE WILL BE NO PRE OR POST BOWLING FOR POSITION ROUNDS EXCEPT IN THE CASE OF AN EMERGENCY. THE LEAGUE BOARD OF DIRECTORS WILL DECIDE ON WHAT CONSTITUTES AN EMERGENCY. ONLY THE LEAGUE SECRETARY CAN MAKE ARRANGEMENTS WITH THE BOWLING CENTER TO SET UP PRE/POST BOWLING. POSTPONED GAMES MUST BE MADE UP BEFORE THE NEXT SCHEDULED WEEK. PRE/POST BOWLING MUST BE MADE AS A TEAM ONLY, NO INDIVIDUAL CAN MAKE UP A PRE**

OR POST BOWL. PRE AND POST BOWLS WILL NOW BE \$5 PER BOWLER TO BE PAID TO THE HOUSE AT THE TIME OF THE PRE OR POST BOWL.

- 11) TARDY BOWLERS: A TARDY BOWLER WILL BE ALLOWED TO ENTER THE CURRENT FRAME IN ANY GAME. IF THE BOWLER ARRIVES BEFORE THE OPPOSING TEAMS ON EACH SIDE COMPLETES THE THIRD FRAME OF THE 1ST GAME, THE TARDY BOWLER WILL BE ALLOWED TO MAKE UP THE MISSED FRAMES. IF THEY ARRIVE AFTER THE COMPLETION OF THE THIRD FRAME OF THE 1ST GAME THEY WILL RECEIVE 1/10TH OF THEIR ABSENTEE SCORE FOR ANY FRAMES MISSED. THERE IS NO CARRY OVER IN SCORE FROM THE MISSED FRAMES TO THE BOWLED FRAMES, (AS WOULD BE WITH A SPARE OR STRIKE).**
- 12) BOWLING UNOPPOSED: THE LEAGUE WILL ALLOW UNOPPOSED BOWLING IN THE CASE OF FORFEIT, ODD NUMBER OF TEAMS, POSTPONEMENTS OR PRE-BOWLING THAT HAS BEEN GRANTED. ANY TEAM BOWLING A FORFEIT MUST BOWL WITHIN 40 PINS OF THEIR TEAM AVERAGE TO WIN THE TEAM POINTS AND THE INDIVIDUAL BOWLERS MUST BOWL WITH IN 10 PINS OF THEIR AVERAGE FOR THE INDIVIDUAL POINTS.**
- 13) POSITION STANDINGS: POSITION STANDINGS WILL BE DETERMINED ON A 35 POINT SYSTEM, WITH ONE (1) POINT AWARDED FOR EACH INDIVIDUAL GAME MATCH, TWO (2) POINTS AWARDED FOR EACH INDIVIDUAL SERIES MATCH, FOUR (4) POINTS AWARDED FOR EACH TEAM GAME MATCH, AND THREE (3) POINTS AWARDED FOR TEAM SERIES. ALL INDIVIDUAL MATCHES WHERE BOTH BOWLERS SCORES EXCEED 300, WITH HANDICAP, WILL RESULT IN A TIE. ALL MATCHES WILL BE BASED ON HANDICAP AS STATED ABOVE. ALL TIES FOR POSITION ROUNDS WILL BE DETERMINED BY TOTALS PINS.**
- 14) ARREARS: BOWLERS WILL BE ALLOWED ONE WEEK ARREARAGE, ANY BOWLER MORE THAN ONE WEEK IN ARREARS (INCLUDING WEEKLY DUES, SPONSOR FEE, SANCTION) THAT**

**BOWLS WILL BE DISQUALIFIED AND HIS/HER SCORES FORFEITED.
ALL MONIES MUST BE PAID INTO THE LEAGUE BY WEEK 12.
AUGUST 17TH, 2026.**

- 15) DROPOUTS: SHOULD A MEMBER QUIT THE LEAGUE, A WRITTEN NOTICE MUST BE GIVEN TO THE SECRETARY OR THE PRESIDENT. THE BOWLER WILL BE RESPONSIBLE FOR TWO (2) WEEKS LEAGUE FEES UNLESS A REPLACEMENT IS FOUND IMMEDIATELY. FAILURE TO GIVE A TWO-WEEK NOTICE IN WRITING WILL RESULT IN A POSSIBLE SUSPENSION FROM PBCBA. IF A TEAM DOES NOT REPLACE THE MEMBER, THE TEAM IS RESPONSIBLE FOR THE LEAGUE FEES UNTIL A REPLACEMENT IS FOUND. A TEAM MEMBER QUITTING THE LEAGUE WILL NOT BE ALLOWED TO REJOIN WITHOUT THE APPROVAL OF THE LEAGUE BOARD OF DIRECTORS.**
- 16) TEAM CAPTAIN DUTIES: THE TEAM CAPTAIN IS RESPONSIBLE FOR THE MEMBERS OF HIS/HER TEAM ELIGIBILITY AND CONDUCT. THE TEAM CAPTAIN SHALL BE RESPONSIBLE FOR MAKING SURE ALL MEMBERS OF HIS/HER TEAM HAVE A VERIFIABLE AVERAGE, AND HAS COMPLETED A SANCTION CARD, INCLUDING ANY SUBSTITUTES. THE TEAM CAPTAIN IS RESPONSIBLE FOR MAKING SURE THE BOWLERS ON HIS TEAM REMAIN CURRENT WITH THEIR WEEKLY FEES.**
- 17) CONDUCT: THE TEAM CAPTAIN WILL BE RESPONSIBLE FOR THE CONDUCT OF THE TEAM. THE LEAGUE AND THE HOUSE WILL NOT TOLERATE THE ABUSE OF BOWLING EQUIPMENT. THIS MEANS NO KICKING OF THE BALL RETURNS, FOUL LIGHTS OR ANY OTHER DAMAGING ACTIONS. THE LEAGUE WILL NOT TOLERATE EXCESSIVE USE OF FOUL LANGUAGE. IF ANY OF THE ABOVE PROBLEMS SURFACE, ALL TEAM CAPTAINS ARE RESPONSIBLE FOR REPORTING THE INCIDENT TO EITHER THE PRESIDENT OR VICE PRESIDENT. IF THE HOUSE AND/OR LEAGUE OFFICER HAS TO STEP IN, ONE VERBAL WARNING WILL BE GIVEN AND ANY FURTHER INCIDENTS, THE BOWLER WILL BE SUBJECT TO**

REMOVAL FROM THE LEAGUE AND/OR BOWLING CENTER. PLEASE NO BOWLING BALLS ON THE COUCHES.

18) POSITION ROUNDS: DIVISIONAL POSITION ROUNDS WILL BE HELD ON THE 7TH WEEK (7/13/26) AND THE 14TH WEEK (8/31/26).

19) LOCKOUT RULE: IF THE FIRST PLACE TEAM IN EITHER/BOTH DIVISION(S) LOCKS OUT THE FINAL NIGHT THEY WILL BOWL USING THE FOLLOWING CRITERIA.

A) IF BOTH FIRST PLACE TEAMS LOCK OUT AND THE SECOND PLACE TEAMS DO NOT, THEN THE FIRST PLACE TEAMS WILL BOWL EACH OTHER.

B) IF BOTH FIRST PLACE TEAMS LOCK OUT AND THE SECOND PLACE TEAM IN EITHER/BOTH DIVISION(S) IS LOCKED OUT AS WELL THEN THEY WILL BOWL THE SECOND PLACE TEAM BASED ON THE RULE AS WRITTEN" ...BOWL THE HIGHEST TEAM IN THE STANDINGS THAT CAN NOT MOVE UP OR DOWN."

C) FIRST PLACE TEAM(S) THAT LOCK OUT ON THE FINAL NIGHT WILL BOWL THE HIGHEST TEAM IN THE STANDINGS THAT CAN NOT MOVE UP OR DOWN.

ALL LEAGUE RULES NOT COVERED HEREIN WILL BE GOVERNED BY THE USBC LEAGUE RULES. THE LEAGUE BOARD OF DIRECTORS WILL SETTLE ANY DISPUTES THAT MAY ARISE. THE BOARD OF DIRECTORS WILL BE FINAL UNLESS AN APPEAL IS MADE TO USBC FOR CONSIDERATION. A RETURN CHECK FEE OF \$25 WILL BE CHARGED BY THE HOUSE FOR ANY RETURNED CHECKS. AFTER ONE (1) CHECK IS RETURNED, FUTURE FEES MUST BE PAID IN CASH.
