

EVERY OTHER SATURDAY CHURCH LEAGUE RULES: '20-'21 2019 – 2020

The league will bowl every other Saturday at 6:35 pm (for practice), 6:45pm, (for score) starting 9-19-20 . thru November 28th, & the next week 12-5, Resuming December 19th (x-mas party).

The league will end on Saturday, May 1st, 2021, PLAY-OFFS, PAY-OFFS & END OF SEASON PARTY)

Teams will consist of 4 members (any mix or all of one gender will be permitted) the league will permit open rosters & open substitutions.

The league will sanction through the PBCBA of the USBC. Sanction dues \$21.00, to the PBCBA will be due by the 2nd week of bowling.

The league fee will be \$15.00 per session, per bowler. (\$11.00 lineage, \$0.50, sec. / treas. fee, & \$3.50 for prize fund.

The league shall bowl with split seasons. 1st half 9 sessions, 2nd half 8 sessions.

The 18th & final session will be for the playoffs, pay-off, & party.

The league president shall appoint 3 bowlers to present prize funds that detail the playoffs & payoffs.

A prize list must be approved by the league's 3rd session.

The 1st half will be paid off at our 10th session. The 2nd half at the 18th session.

Pins Over Average format will be used to determine winning points. (100% handicap)

Game & Total points are won by the team that has the highest POA.

The league will use a 7 point system, 2 points for each game won and 1 point for total.

Average criteria for individuals are as follows:

- a) 2019-2020 E.O.S. Church League's 21 or more game average.
- b) 2019-2020 highest yearbook average.
- c) Highest 2020, 21 or more games summer league average.
- d) If none of the above, they'll establish an average with their 1st 3 games.

The vacancy score will be 130.

The absent score will be the absent bowler's average minus 10 pins.

After 2 consecutive sessions, using absentee scores, teams must use vacancy scores.

One bowler will be a legal line-up. (Forfeiting teams cannot win any points.)

Each half will have 2 position rounds; 5th & 9th sessions (1st) 13th & 17th sessions (2nd)

Resigning bowlers must give a written 2 week notice and are responsible for those 2 weeks league

fees (unless they're replaced) Failure to do so can result in that bowler's suspension from the USBC.

Pre & Post bowling are allowed with the following conditions.

Team captains are to request pre & post bowling with the sect./treas. & bowling center, prior to the next session.

Individuals can pre-bowl, but only teams can post bowl.

All league funds will be banked with Greenacres Bowl. (checks made to GAB) NSF checks will be charged \$25.00

The above rules will be in conjunction with USBC rules.
